- g) Bids must be accompanied by Bid security (Bid Earnest Money EMD) of the amount specified for the work in the Table -A below. The EMD shall be in the form of Fixed Deposit Receipt of a scheduled commercial bank, issued in favor of **Madhya Pradesh State Open School education Board Bhopal payable at Bhopal.** The Fixed Deposit Receipt shall be valid for six months or more after the last date of receipt of bids. However, other form(s) of EMD may be allowed by the Employer by mentioning it in the Bid Data Sheet.
- h) Bids must be delivered to office of the Director Madhya Pradesh State open School Education Board, Madhyamik Shiksha Mandal Campus Shivaji Nagar, Bhopal 462011 **on or before 15:30 hours on 22/06/2021 (date) and will be opened on the same day at 17:30 hours**, in the presence of the bidders who wish to attend. If the office happens to be closed on the date of receipt of the bids as specified, the bids will be received and opened on the next working day at the same time and venue.
